

JANUARY 9, 2007

The Harriman City council met in regular session Tuesday January 9th, 2007 at 7:30 p.m. in the Conference Room of the Harriman Municipal/Utility Building. The Honorable Jerry Davis Mayor was present and presiding. Mayor called meeting to order. Roll call of Council was as follows:

Mayor Davis asked for a motion to approve the minutes from 01/02. Councilmember Mason made the motion and Councilmember Gallaher seconded the motion. The motion passed with a unanimous "Aye".

Mayor Davis asked for a motion to pay the bills. Councilmember Mason made the motion and was seconded by Councilmember Morris. The motion passed with a unanimous "Aye".

Mayor Davis called to hear delegations.
No one approached council.

OLD BUSINESS

STREET LIGHTS- Councilmember Sampson asked council to consider putting up street lights from Clayton Homes to the city limits. Councilmember Sampson stated that maybe the city could have the Harriman Utility Board put up the lights. Councilmember Morris stated that the lighting that was done in Midtown was done mostly with grant money and the city should probably check into getting grants for these lights. Mayor Davis suggested getting the City Coordinator look into this.

CITY COORDINATOR- Councilmember Sampson asked council to decide if the city coordinator should be working on the web site or the Pine Ridge Road project. Charles Kerley, treasurer, stated that Dennis Ferguson told him the Pine Ridge Road Project was on the schedule. He recommended having Bob Tidwell coordinate a meeting with Dennis Ferguson and Gerald Nicely. The motion was made by Councilmember Sampson and seconded by Councilmember Mason. The motion passed with a unanimous "Aye".

WATER DAMAGE- Councilmember Morris stated that on the road behind McDonalds the road is being washed away by the water that needs to be channeled to go under the bridge. Mayor Davis stated he would have Drack Langley, Street Supervisor, look into it to see what could be done.

ORDINANCES-Councilmember Mason stated that he wants to hire an attorney to write up an ordinance for merchants not to display merchandise on the outside of businesses. The motion was made by Councilmember Mason and seconded by Councilmember Sampson. The vote passed with a unanimous "Aye". It was decided to get a recommendation from the City Attorney, Harold Balcom.

PINE RIDGE ROAD PAYMENT-Charles Kerley stated that the Mayor had received a letter from the State of Tennessee regarding an additional payment of \$107742.65. After discussion it was decided to postpone the payment until February and find out what the payment is actually for.

BUILDING-WOODY STREET-Chief Heidle asked council to approve him to get bids on a new heating and air unit for the house on Woody Street that the police department would be using. The motion was made by Councilmember Wright and seconded by Councilmember Morris. The motion passed with a unanimous "Aye".


AGENDA

GOLF COURSE EQUIPMENT-Mayor Davis stated that the golf course needs reels for the game mower, a new trim mower and a used tractor. Mayor Davis stated that bids could be put out for the mowers. Councilmember Mason suggested getting the tractor from the state surplus. The motion was made to purchase these items by Councilmember Tedder and seconded by Councilmember Mason. The vote passed with a unanimous "Aye"

RECREATION COMMITTEE- Mayor Davis stated that he wanted to defer this item until further notice.
